- 3) The Multi Storeyed Building Inspection Committee vide reference 6th cited, have inspected the premises of the Multi-Storeyed Building Stilt + (05) Upper Floors with a height of 18.90 Mtrs. for Educational Occupancy (B2) M/s. Sanskriti Educational Society, Golden Tulip Estate, at Plot No.16, 16A and 17, Kondapur, Ranga Reddy District and reported that the Fire Fighting systems item-wise were randomly checked/tested and found in good

working condition and recommended to issue Renewal of No Objection Certificate for Occupancy.

4) In view of the above, and as per recommendations of the Multi Storeyed Building Inspection Committee, the Renewal of No Objection Certificate for Occupancy is issued to the Multi Storeyed Building with Stilt + (05) Upper Floors with a height of 18.90 Mtrs. for Educational Occupancy (B2) M/s. Sanskriti Educational Society, Golden Tulip Estate, at Plot No.16, 16A and 17, Kondapur, Ranga Reddy District subject to the following conditions:

It is the responsibility of the management to apply for renewal of No Objection Certificate duly remitting the user charges as per the G.O.Ms.No.71, (Home Prisons-A) Dept., Dt: 01-04-2010, two months before expiry of the certificate.
